 - Application can scanned and emailed to cornerstoneteen@yahoo.com or mailed to *Cornerstone Teen Center Shooting Sports, PO Box 394, Nezperce, Idaho, 83543.*
 - The child (applicant) shall hand-write a (1) page essay explaining , 1) why they want to participate in the program, and 2) how they think they will benefit. This essay should be submitted with the application. *(Can use standard lined paper using pen or pencil. Recommend at least ¾ page of content. It's more about content but spelling and neatness does matter as this will be used to select participants).*

- 2. If your child is selected, complete all (3) SASP registration requirements before 5 Nov 2021.**
 - (3) SASP forms are required.
 - The **Athlete Consent and Waiver Form** will be completed electronically through the SASP portal (link to be provided if selected). *SASP fees will be paid when form is completed.*
 - The **Sportsmanship Contract Form** and the **Medical Consent Form** will be downloaded from the SASP site (link to be provided if selected) and submitted to the teen center at the address above. *Club fees will be submitted with these forms.*

- 3. If your child is selected, pay all fees (totaling \$75) before 5 Nov 2021.**
 - SASP fee of \$25 will be paid through the SASP portal when completing the Athlete Consent and Waiver Form.
 - Club fee of \$50 will be submitted with the Sportsmanship Contract Form and the Medical Consent Form.
